

APPENDIX 3

Candidates for Public Office Endorsed by or Mentioned in the *Echo*

Each entry lists the candidate's name, the office for which he is running, the candidate's party if noted by the paper (indicated by "D" for Democrat), whether the candidate is endorsed (indicated by "E"), and the date. Multiple publication dates for the same information, such as C. P. Trimm for Circuit Clerk, are not given; the first mention of a candidate is that which is recorded in the registry. In addition to the date, the page and column of the reference is given: 4-28, 5:3 refers to page 5, column 3 of the April 28, 1892 edition.

- Armistead, H. B.: Secretary of State, candidate from Franklin County (D, E), 3-24, 2:4; additionally endorsed in letter to editor from Logan County, 4-14, 3:3
- Baerlocher, Emil: Logan County Assessor (D, E); endorsed by letter from thirty-two German-speaking citizens of Logan County who wanted to elect a fellow German-speaker, also mentioned several times he was fluent in both English and German, 4-28, 5:2
- Barrow, John: Representative for Pulaski County (E), 6-9, 2:4; writes a letter to the editor and asks for it to be translated into German so he can address readers directly, 7-15, 2:3
- Blackwood, W. F.: County Judge (county not indicated; D, E), 3-31, 2:3
- Blanks, E. B.: sheriff of Pulaski County (D, E), 6-2, 5:1
- Blass, Gus: Big Township Justice of the Peace (D, E), 8-19, 5:1
- Bond, John B.: Pulaski County Coroner, 4-14, 3:1; report that he received Democratic nomination, 7-22, 5:1
- Brodie, John: County Clerk (county not indicated; D, E), 3-24, 2:4; report that he received Democratic nomination, 7-22, 5:1

- Callaway [alternately Galloway or Calloway], J. W.: Senator (D, elected); report that he received Democratic nomination, 7–22, 5:1
- Churchhill, Ham. Z.: Representative (D, E—elected); stated that he has always been in favor of German immigration and should be supported in opposition to candidates who supported three-mile laws for Prohibition, 7–15, 5:2; report that he received Democratic nomination, 7–22, 5:1
- Clark, E. O.: Pulaski County Circuit Clerk (D, E), 3–24, 2:4
- Colquitt, John W.: Assessor, noted that he lost a leg in the Civil War fighting for the Confederacy, which endeared him to English speakers, but that he is a good civil servant, which means the editor has nothing against him: 6–16, 8:1; report that he received Democratic nomination, 7–22, 5:1
- Cowpland, John: County Treasurer (county not indicated; D, E), 3–24, 2:4; report that he received Democratic nomination, 7–22, 5:1
- Compton, W. A.: Pulaski County Judge (D, E), 3–24, 2:4; report that he received Democratic nomination, 7–22, 5:1
- Conway, Francis: Pulaski County Surveyor (D, E), 3–17, 2:5; another print endorsement citing his years of experience, 7–7, 5:3
- Dickinson, W. W.: Big Township Justice of the Peace (D, E), 8–19, 5:1
- Elsken, Conrad: Treasurer of Logan County (D, E, elected); lengthy article discussing his accomplishments, 3–3, 2:3; additionally endorsed in letter to editor from Logan County, 4–14, 3:3
- Emmich, Isaac: Big Township Justice of the Peace (D, E), 8–19, 5:1
- Erb, Jakob: County Judge (Pulaski, but county not indicated by *Echo*; D, E), 3–31, 2:3
- Fischbach, W. M. [William Meade Fishback]: Governor (D, E, elected), 4–7, 3:1
- Fletcher, F. M.: Big Township Justice of the Peace (D, E), 8–19, 5:1
- Fletcher, John G.: suggested as welcomed potential gubernatorial candidate, 2–25, 2:2
- Flucks, Dr. Carl: Representative (elected); resident of Oppelo mentioned as candidate for representative in the primaries and praised for being highly intelligent and willing to represent German interests, as a fellow German, regarding immigration and Prohibition (E), 7–29, 5:1
- Fones, D. G.: Big Township Justice of the Peace (D, E), 8–19, 5:1
- Fowler, Chas. F.: Alderman, fourth ward of Little Rock (E), 3–10, 2:1
- Galloway, W. A.: Representative (D, elected); report that he received Democratic nomination, 7–22, 5:1
- Geyer, Ino. E.: Big Township Justice of the Peace (D, E), 8–19, 5:1
- Grambling, L. C.: Big Township Justice of the Peace (D, E), 8–19, 5:1
- Greenwood, William M.: Logan County Probate Judge (D, E), 3–24, 2:5; additionally endorsed in letter to editor from Logan County, 4–14, 3:3

- Harvey, [first name not given]: candidate for Logan County office; correspondent from Prairie View encourages Germans not to vote for him, 9-2, 5:2
- Hemingway, W. E.: Associate Justice of the Supreme Court (D, E), 8-19, 5:1
- Hicks, J.: Chancery Clerk (D, E), 6-16, 8:1; report that he received Democratic nomination, 7-22, 5:1
- Hopkins, J. T.: Big Township Justice of the Peace (D, E), 8-19, 5:1
- Jones, Abel: Representative (D); report that he received Democratic nomination, 7-22, 5:1
- Kinkead [alternately spelled Kinkhead], Ewing: Big Rock Township Constable (D, E), 4-28, 8:2; report that he received Democratic nomination, 7-22, 5:1
- Kirk, W. J.: Big Township Justice of the Peace (D, E), 8-19, 5:1
- Koers, Louis: Alderman, second ward of Little Rock (E), 3-10, 1:7
- Kramer, Chas.: Alderman, second ward of Little Rock (D, E), 3-10, 1:7
- Kumpe, C. H.: Constable (E), 6-9, 8:1; reader endorsement as well, 6-30, 8:5
- Landsberg, S.: Big Township Justice of the Peace (D, E), 8-19, 5:1

- Linhardt, Jos.: Faulkner County Coroner (mention without direct endorsement), 7-29, 5:1

- Merrick, G. A.: Surveyor (D), report that he received Democratic nomination, 7-22, 5:1
- Mills, Anderson: Sheriff (D, E); group of readers state they have nothing against his opponent but that a better sheriff could not be found, 7-15, 5:2; report that he received Democratic nomination, 7-22, 5:1
- Mitchell, J.: Little Rock School Board (E), 5-12, 7:5
- Monroe, C. T.: Pulaski County Representative (E), 6-30, 8:4
- Morrow, R. B.: State Treasurer (D, E, elected), 8-19, 5:1
- Murphy, Wm.: Big Township Justice of the Peace (D, E), 8-19, 5:1
- Myers (alternately Meyers), C. B.: Commissioner of State Lands (D, E, reelected), 5-5, 6:4; 8-19, 5:1; reader letter offers unflattering portrait of his treatment of German farmer and asks whether they should really vote for him; editor noted that the facts of the matter were not certain and wished the information had been received before the primary; Germans admonished to still vote for this Democratic candidate, 9-2, 5:2
- Neil, Rob. Gen.: Sixth Congressional District Representative (mention without direct endorsement), 7-29, 5:1
- Parsel, Tom: Big Township Justice of the Peace (D, E), 8-19, 5:1

- Peay, W. N.: Pulaski County Coroner (D, E), 3-17, 2:5
- Pemberton, Cal.: Sheriff of Pulaski County (D, E), 7-7, 5:3
- Pemberton, Walter H.: Prosecuting Attorney for the Sixth District Court (D, E), 3-31, 2:3
- Penzel, Chas. F.: Big Township Justice of the Peace (D, E), 8-19, 5:1
- Pollock, M.: Big Township Justice of the Peace (D, E), 8-19, 5:1
- Ramsey, E. A.: City Clerk in Argenta, 4-7, 3:1; reader endorsement as well from a fellow farmer; noted that Ramsey served in the confederate army and was a loyal democrat, 6-30, 8:4; report that he received Democratic nomination, 7-22, 5:1
- Rankin, W. H.: Big Township Justice of the Peace (D, E), 8-19, 5:1
- Reinberger, Beni F.: State Representative (D, E), 7-15, 2:6; praised as a fellow German and endorsed by Carl Eisenhardt and other readers.
- Robbins, Hiram: Big Township Justice of the Peace (D, E), 8-19, 5:1
- Roberts, Ch. P.: Representative (D, elected); report that he received Democratic nomination, 7-22, 5:1
- Rose, John M.: Big Township Justice of the Peace (D, E), 8-19, 5:1
- Shinn, Josiah H.: State Superintendent of Public Instruction (D, E), 8-19, 5:1
- Snyder, John: Conway County Assessor (E), 5-5, 6:4
- Steed, Ino. H.: Big Township Justice of the Peace (D, E), 8-19, 5:1
- Sumpter, John J. [alternately as Ino. J.]: Second Congressional District; candidate from Hot Springs (D, E, elected), 3-24, 2:4
- Terry, W.[illiam] L.: reelection to the Fourth Congressional District (E), 5-12, 6:4
- Thomas, D. A.: Big Township Justice of the Peace (D, E), 8-19, 5:1
- Thomas, D. A.: Little Rock School Board (E), 5-12, 7:5
- Trimm, C. P.: Circuit Clerk in Paris (D, E), 1-14, 1:6
- Wehrfritz, E. C.: Alderman, second ward of Little Rock (E), 3-3, 2:5
- Williams, S. A.: State Auditor (R, E); praised by a correspondent as an excellent former mayor of Fort Smith and someone who speaks German with his family in his home, 8-19, 5:2; praised in another correspondent letter by Civis, who urges Germans to vote a straight Democratic ticket with the exception of Williams, who should be voted for even though he is a Republican because he is a "real, German man," 8-26, 5:4; correspondent F. V. from Fort Smith also praised candidate and encouraged all Germans to vote for him regardless of party, 9-2, 5:3
